***Options related to whether a motion has a "vote required," is "debatable," "amendable," or one is allowed to "interrupt a speaker":**

1. Yes, if applied to a debatable motion
2. Yes, if the main motion pending is debatable, but is limited to the matter being appealed.
3. Majority, unless adoption of the motion requires a two-thirds majority because of suspending the rules.
4. Yes, if the motion to which it relates was debatable.
5. Yes. If the time limit is about to expire, then the motion may be entered on the minutes for later consideration.
6. Majority, except where the rules of order are about to be rescinded, when it requires a two-thirds majority vote of those present and voting, and also when a two-thirds majority vote was required in the first place to adopt.
7. Yes, but only as to time, duration, and reasonableness if other business is pending when it is removed. These have some restriction and are noted in the section where the motion is discussed.
